The charge for storing boats at Chiswick is £20 per boat per year.

Notes:

- Storage is only available to Ordinary, Associate or Family members of the Club – non-members may only store boats which are declared (and accepted by the Club) as available for use by the Club (as below)
- The charge is a flat rate, which applies for the Club's financial year (1 Jan-31 Dec), regardless of how often or for how long a boat is stored during the year (ie no pro rata charges). Charges would normally be billed at the beginning of the financial year, or when a newcomer first stored their boat(s).
- The Club does not insure private property stored at Chiswick (it is the owner's responsibility to make arrangements as appropriate), and does not accept liability for loss of, or damage to, such property.
- Charges may be waived, at the discretion of the Club's officers (subject to ratification by the Committee), in respect of a boat which is notified to the Club as being available for Club use. The aim is to ensure that the waiver is legitimately applied, rather than simply as a means of avoiding charges. The waiver applies only if a boat is in practice likely to be used by the Club, with normal charges levied and income going to the Club; it would be granted on the assumption that income from the boat should exceed the storage charge that would otherwise arise – if this does not occur, the Club would reserve the right to levy the normal charge. It is expected that this waiver will apply only in respect of a member's "second boats".
- The Club's officers (subject to ratification by the Committee) may, at their discretion, waive charges for short-term, purely temporary storage.
